2. Pursuant to FSL 121819.GEN, the service provider must undergo an audit for compliance with Resolution MSC.402(96) not later than **12 September 2024**, the expiration date of the Certificate of Approval No. **21-4886913-A** issued by **American Bureau of Shipping**.

3. Service engineers shall have valid Authorization Certificates, issued by the Approved Service Provider or by the equipment manufacturer, which defines their level of qualification and the scope of the certification (e.g., makes and types of equipment).

4. The service provider shall maintain valid manufacturers' authorization certificate for all equipment to be inspected and serviced.
